One microprocessor is dedicated to the control of the power supply and measuring circuitry, while the second is dedicated to the user interfaces and printer control. To ensure operator safety, the microprocessors communicate via an optical link, thus isolating the operator controls from the dangerous high test voltages inside the unit.
